Cancellations must be received by 3:00 pm Friday April 18 to 928-636-2969, in person at CVUMC or email chinovalleyumc@gmail.com. A \$10 administrative fee will not be refunded. No refunds will be given for renter cancellations, including illness, requested after the Friday deadline. Only the church can decide if inclement weather warrants event cancellation and issuing refunds.

- All vendor booth display equipment, tables, canopies, etc., must be provided by the vendor.
 Booths and display area must be clean and attractive. Items displayed on the ground must be
 maintained in a neat condition. Vendors must control and remove all trash at the end of the
 event.
- Vendors may not set up or place merchandise for sale or exhibit outside their assigned space perimeter. Any vendor whose booth exceeds the assigned space will be expected to either modify the booth so that it fits into its assigned space or relocate it if modifications are not possible, so please measure your booth carefully and include walkways or overhangs if necessary for your exhibit. Vendors requiring larger area will need to purchase additional adjacent space(s).
- 3. All booths must be freestanding, and no stakes or tie-down ropes are allowed.
- 4. Event representatives reserve the right to relocate, move or remove from display any merchandise or equipment believed to be a nuisance, hazard, objectionable to good taste, or not within the intention of the event.
- Should you wish to not take anything home, a non-profit organization will be on site for your donations.
- 6. The Chino Valley United Methodist Church will not provide vendors direct access to electricity; a common electrical outlet will be provided by the church for customers to test electric items that vendors have for sale; gas powered generators are prohibited; vendors are allowed to provide electrical service to their booth using only small solar sources or commonly available battery-powered sources.
